

Bill Donegan, CFA, Orange County Property Appraiser

First elected to public office in 1986 as a city councilman for Maitland, Florida, Mr. Donegan was elected Orange County Commissioner in 1988 and re-elected to serve an additional four year term in 1992.

During his tenure as a County Commissioner he served as Chairman of the following boards:
